(Repealing Resolution 97-3)

WHEREAS, the Nehalem Bay Wastewater Agency passed Ordinance 91-3 establishing the System Development Charge, and

WHEREAS, Resolution 95-2 established a System Development Charge Methodology to calculate the SDCs shown in Exhibit "A", and

WHEREAS, System Development Charges will be assessed using the classification method established in Exhibit "A".

WHEREAS, In the future any building, account or business that changes from a lower to a higher classification will be assessed at the higher rate, with the difference in these charges paid, to the Agency, at the time of the change

IT IS THEREFORE RESOLVED that the System Development Charge, Connection Charges and assessment method, as outlined in Exhibit "A", Shall become affective July 16, 1997.

IT IS FURTHER RESOLVED that Resolution 97-3 shall be repealed as of July 16, 1997.

SYSTEM DEVELOPMENT CHARGE CLASSIFICATION ADDITION (An Addition to Resolution 97-9, Classification Method, Exhibit A)

WHEREAS, the Nehalem Bay Wastewater Agency passed Ordinance 91-3 establishing a System Development Charge for capital improvements associated with the collection system and wastewater treatment plant, and

WHEREAS, Resolution 95-2 established a System Development Charge Methodology to calculate the System Development Charges, and

WHEREAS, Resolution 97-9 established the classification method for assessing System Development Charges, and

WHEREAS, additions to the classification method list needs to be done to comply with the changes in the use of the sewer system,

THEREFORE, classification #18 is added to the list as follows:

18. Adult Foster Homes/Group Homes, each two beds = 1 System Development Charge Kitchen/Food Service added with 11 or more beds = 2 System Development Charge (One bed would not require additional charges)
