Projects Update

Disinfection Plan: The plan has been submitted to DEQ and we are waiting for approval.

System Development Charge Update: Kennedy Jenks is working on an updated methodology for our System Development Charge. This is a requirement of ORS 223.297-223.314 and in conjunction with our updated Master Plan of 2014-2034. Rob Peacock of Kennedy Jenks will present the material at the September Board meeting. Director Nicholson asked what the methodology was. Manager Halverson explained the cost analysis of current assets, replacement costs, and system maintenance.

Projects Update Continued

Eastside of Hwy 101 NKN Mountain ("The Summit"): This property is within our service boundary and we would allow an extension if the line ran down Hwy 101 to the manhole by Patty Rinehart's property. NKN water has stated they will not supply water to the proposed 30 2 acre lots. There is a possible zoning issue with Tillamook County. Director Nicholson stated that the City of Manzanita would not annex the development into the city.

Manzanita Village (Driving Range Project): Nothing new to report. Director Nicholson reported that they have yet to submit an application to the city. Director Nicholson stated that they would not receive 100% short term rental zoning.
