MANAGER'S REPORT

Irrigation: Still doing one set a day due to lack of rain. It is possible that we will have to shut irrigation down early if this weather continues. That too would be a first.

Levee Maintenance: By the time we get the bid packets out to contractors and they prepare for the work, our in-water work window would be up. Our permit is good until 2027. We are going to postpone the actual work until the in-water work window opens July 2024. This will give us time to get the packets out, and we can get the 256 willow sticks that are required. It's been over five years, what's another eleven months, right?

Wheeler North: Kennedy Jenks is working on the 60% plans and on the bid packets.

<u>River Gauge:</u> Nothing new.

Echanie Court: During a routine point repair that C-More Pipes was attempting, the line collapsed. The line didn't totally plug but their bladder and point repair equipment were stuck. We were able to find a contractor (Advanced Excavation) to come in and dig up the 15' deep mainline that flows from the parking area of the apartments to our Bayside North pump station. Advanced Excavation was already responding to an emergency in Rockaway so the job started later in the day and lasted until around 1:00am. We will have to work on a plan to rehab that entire line. It will be a major task involving mass shoring and sand points. I'm not even sure sleeving it would work. I'm also going to talk to Kennedy Jenks about the possibility of shallowing up the line. There really isn't any good reason it has to be that deep. That option comes with its own difficulties as well.

The Auditors will be here on August 28th.
